- 1122.03 **Residents** present raised the following matter and where relevant they are listed together with the actions that will be taken, if required. In due course, if necessary, reports will be made back to the Council.
 - **Ryal village.** A resident attended the meeting to express concerns over a potential unauthorised development on land north of Ryal church. Contractors working on the site had advised that they had been installing water pipes for a proposed glamping/camping site. This area does not have planning permission. It was also noted that waste is being brought to the site to be burnt. This will be reported to Planning Enforcement for them to investigate further.

1122.09 Village Issues and Highways Matters

- a) To receive reports from councillors on any village issues/highways matter which require attention.
 - i. Jubilee Garden. A huge amount of work had been done to improve the Jubilee Garden and thanks were expressed to the volunteers and in particular Liz Bishop for all of the work she had carried out. The garden is now dormant for the Winter and we look forward to seeing the garden in the Spring.
 - ii. **Flooding in Ingoe.** Cllr S Greaves had reported an issue with flooding in Ingoe. NC Highways had agreed to have the gullies checked and cleaned including the soakaways and ditches.
 - Update on the Community Plan following the meeting with Northern Powergrid. iii. Cllr K Mavin and Rachael Dempsey had met with Helen Priestley, Stakeholder Engagement Manager from Northern Powergrid regarding the recent application to their Resilience Fund to develop the Village Hall to be more able to support the community in the event of a climate emergency as outlined in the published Community Plan. Helen explained that we should have included some form of energy protection measures in the application as this was the most fundamental part of having some form of community hub/warm space etc. We had been led to believe that Northern Powergrid would be supplying a generator in the event of any kind of emergency. This had been mentioned in the various meetings with Northumberland Communities Together. Unfortunately, this now means that our application for village hall improvements is not valid and that we have to have any electrical inspection done at our own expense. Fortunately, a resident had offered to take on the task of obtaining an electrician to carry out a survey of the Village Hall to establish the specification of generator that would be suitable to supply the Village Hall and the requirements for the necessary modifications that would need to be made to the existing electrical apparatus in the hall. Once we have this information we will be able to resubmit our application to the Northern Powergrid Resilience Fund.

- a) Chairman. Cllr K Mavin advised that he will resign from the Parish Council at the annual meeting in May. The lack of response from Northumberland County Council, in all departments, including Planning, Highways, Northumberland Communities Together etc is becoming increasingly frustrating.
