0124.01 TO RECEIVE QUESTIONS FROM RESIDENTS IN RELATION TO MATFEN PARISH.

- a) The Black Bull. Residents of Matfen attended the meeting expressing concerns that the Black Bull Public House remains closed and in particular they expressed concerns that the owner will apply for planning permission for change of use to a residential property. The owner of the pub later attended the meeting and gave an update. Unfortunately, the family had to move downstairs due to the upstairs being uninhabitable. A lot of work needs to be carried out to make the upstairs habitable again. She gave assurances that the pub will reopen however is not able to give a timescale. The problem with the rubbish in the car park had been a misunderstanding with the skip company and this has now been resolved. Work will be carried out at the front of the pub including grass removed and flagstones laid; sign on the pole removed and placed on the side of the building. Residents offered to help in any way they could.
- b) **Sports Field.** Residents asked if dogs were allowed on the sports field. Yes, they are as long as dog owners have them under control and pick up any mess. Problems with dog fouling continues to be a problem.

- 0124.03 **DECLARATIONS OF INTEREST.** None.
- 0124.04 **MINUTES OF THE MEETING HELD ON 28th NOVEMBER 2023.** It was proposed by Cllr J Dempsey seconded by Cllr K George and RESOLVED to accept the minutes as an accurate record.
- 0124.05 ACTIONS TAKEN FOLLOWING THE MEETINGS HELD ON 28th NOVEMBER 2023. None
- 0124.06 **TO CONSIDER CO-OPTION TO FILL ONE VACANCY.** It was proposed by Cllr J Dempsey, seconded by Cllr K George, and AGREED to co-opt Thomas Webb onto Matfen Parish Council. Mr Webb accepted and signed his declaration of acceptance of office in the presence of Mrs M Senior, Clerk to the Council.
- 0124.07 **COUNTY COUNCILLOR'S REPORT.** County Councillor Mrs V Jones gave her verbal report on matters relating to Northumberland County Council and the parish of Matfen.
 - a) **NCC Budget.** The consultation on the budget had closed and will be finalised in the next few weeks. There are to be no cuts to front line services.
 - b) **Roads.** NCC is aware that the roads are falling apart and they are struggling to keep up with the amount of potholes. Discussions are ongoing as how best to tackle this. They are also looking into the frequency of gulley cleaning. An email had been received from a resident regarding the recent flooding in Matfen and also on the road to Fenwick. It was

- noted that the field drains are often blocked and not maintained which leads to these problems.
- c) **Fix My Street.** The new way of reporting issues to NCC 'Fix My Street' is working well and is identifying problem areas around the County.
- d) **Planning Application Land North of Ingoe Chapel.** Cllr Mrs V Jones had objected to this application. There had also been objections from NCC Ecologist and Highways. NCC are yet to determine this application.
- e) **Grit Bins.** Cllr Mrs V Jones asked if there were any areas which need additional grit bins. A request was made for a grit bin on Ryal Banks. The Parish Council will pay for this to be filled after the initial fillings by NCC.
- f) LTP Fenwick 30mph zone. This is still to be implemented and Cllr Mrs V Jones will chase this up.

0124.08 **FINANCE**

- a) **Accounts for payment**. It was proposed by Cllr J Dempsey, seconded by Cllr K George and AGREED accounts on the list attached be paid.
- b) **To consider financial support to Tynedale Hospice at Home.** It was AGREED to make a contribution of £200 to the Tynedale Hospice at Home. The clerk will arrange payment.
- c) To consider transitioning to gov.uk email addresses and obtaining gov.uk website domain. After discussion, it was RESOLVED to transfer the website to a gov.uk website and create gov.uk email addresses for all councillors and the clerk. There is a grant of £100 available to assist with obtaining the first year's domain however the total cost will be no more than £150.00.
